

## 'Win a trip of a lifetime to Melbourne' Contest General Terms and Conditions.

## Prize overview and terms and conditions

Prizes: ONE (1) GRAND PRIZE: Return flights for two (2) round-trip fare only tickets in economy class to be used for travel between Singapore (SIN) and Melbourne (MEL) 3 nights' accommodation and 3 days car rental in Melbourne.

The prize winner must be aged 18 years or over at the time of entering the contest. The prize winner must inform the promoter of their acceptance of the prize within 10 days of the prize winner being announced. We regret that the prize winner must travel in order to take up this prize, it is not transferable. In the event that the winner is unable to take up this prize a second winner will be drawn at random.

## Full terms and conditions

## Official Rules:

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility: 'Win a trip to Melbourne' (the "Promotion") is open only to legal residents of the Singapore who are at least eighteen (18) years old at the time of entry. Subject to all applicable federal, state, and local laws and regulations. Void where prohibited. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Main Sponsor's ('Travix Travel Singapore Pte Ltd') decisions, which are final and binding in all matters related to the Promotion. Winning a prize is contingent upon fulfilling all requirements set forth herein. The Promotion consists of a sweepstakes (the "Sweepstakes"). 2. Timing: The Promotion begins on 27 November 2017 and ends on 31 March 2018 (the "Promotion Period"). The winner will be announced on 3 April 2018 on the CheapTickets.sg website and facebook page. 3. How to Enter: During the Promotion Period, enter on the CheapTickets.sg website on www.cheaptickets.sg/australia. You will automatically receive one (1) entry into the Sweepstakes on completion of the application. All potential winners are subject to verification before any prize will be awarded. Sponsor is responsible for the functionality of the Sweepstakes.

Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Main Sponsor is not responsible for any lost, late, incomplete, invalid, unintelligible or misdirected registrations, which will be disqualified. In the event of a dispute as to any registration or play, the authorized account holder of the email address used to register will be deemed to be the registrant or player. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winners may be required to show proof of being the authorized account holder.

4. Sweepstakes: Winners are final and binding in all matters related to the Promotion. 5. All potential winners

are subject to verification by main sponsor, whose decisions are final and binding in all matters related to the promotion. an entrant is not a winner of any prize, even if the sweepstakes should so indicate, unless and until entrant's eligibility has been verified and entrant has been notified that verification is complete. Main sponsor will not accept screen shots or other evidence of winning in lieu of its validation process. Any play that occurs after the system has failed for any reason is deemed a defective play and is void and will not be honoured.

6. Verification of Potential Winners: Potential winners must continue to comply with all terms and conditions of these Official Rules and winnings are contingent upon fulfilling all requirements. Each potential winner will be notified by email or phone. If a potential winner of any prize cannot be contacted within the required time period (7 days), or prize is returned as undeliverable, such potential winner forfeits the prize. In the event that the potential Prize winner is disqualified for any reason, Main Sponsor will award the Prize to an alternate winner by random drawing from among all remaining eligible entries. All alternate potential winners are subject to all requirements set forth in these Official Rules.

7. Prizes: ONE (1) GRAND PRIZE: Return flights for two (2) round-trip fare only tickets in economy class to be used for travel between Singapore (SIN) and Melbourne (MEL) 3 nights accommodation and 3 days car rental in Melbourne.

The prize winner must inform the promoter of their acceptance of the prize within 7 days of the prize winner being announced. The travel for this prize must be booked by 30 April 2018. Travel may not be within 30 days of informing preferred travel dates. Travel must be completed by 30 November 2018. We regret that the prize winner must travel in order to take up this prize, it is not transferable. In the event that the winner is unable to take up this prize a second winner will be drawn at random. Whilst it may be possible for the winner to extend their trip at the organisers discretion the total period of travel must be 30 days or less. The winner must be aged 18 or older at the time of contest entry.

Flight conditions: Blackout dates for flight departure from Singapore: 14-16 April, 28 April- 1 May, 22 June- 16 June, 30 Aug- 3 Sept 2018. Once passengers' details have been submitted they are not able to be changed. Name corrections (same passenger) after tickets are issued are charged at CheapTickets.sg and airline prevailing rates at time of change, starting at \$120 SGD. Winner and guest are solely responsible for their own conduct while accepting the prize and agree to comply with all applicable laws and regulations pertaining to use and enjoyment of the prize. Once flight taxes are paid in full and the bookings are confirmed, winner will receive an E ticket confirmation. Once the tickets have been issued, they are non-refundable, non-transferable and no modifications are permitted. It is the responsibility of the travelling party to ensure that they have valid passports and visas for travel. CheapTickets.sg recommends the purchase of travel insurance prior to travel.

Hotel conditions: 3 night's hotel accommodation. Hotel allocated will be at the organisers discretion. Accommodations will be either hotel or apartment style. If prize winner wishes to upgrade or change hotel they may do so bearing the extra price difference on the day of booking between the hotels where applicable. Changes are at the organisers discretion. Once hotel has been booked all costs for changes or cancelations must be borne by the prize winner.

Car rental: Prize winner will be given 3 days car rental. Car rental collection will be either in Melbourne CBD or at airport. An economy car rental to fit 2 passengers and 2 suitcases will be allocated. Prize winner is responsible for having a valid driving licence for driving in Australia. Prize winner is responsible for all fines associated with car rental including speeding and parking tickets. CheapTickets.sg recommends taking a 0 excess policy for car rentals in Australia to insure against accidents. Limitations of Liability: The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment or programming associated with or utilized in the Promotion; (2) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Promotion; (4) technical or human error which may occur in the administration of the Promotion or the processing of entries; or (5) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Promotion or receipt or use or misuse of any prize.
